Relevant contextual information about your school and School Development Plan:

- Marshall Springs is a diverse learning community welcoming learnings from grade 6-9. We have approximately 660 students, mainly from the communities of Evergreen and Walden.
- Each of our classrooms is equipped with a digital display to promote visual learning, as well as access to Chromebooks to support student learning.
- The school's Learning Commons has a large print-based fiction and non-fiction book collection for students to borrow and read.
- Our School Development Plan focuses on the follow areas in Literacy, Numeracy, and Wellness:
 - -Literacy: Reading Comprehension.
 - -Numeracy: Number Sense.
 - -Wellness: Sense of Belonging.
